Purposes of the processing for which personal data are intended, as well as the legal basis of processing	GRUPPO PIANTONI HOLDING Srl processes the subjects' personal data for the following purposes: <ul style="list-style-type: none"> - Selection, establishment, management and execution of the contractual and/or pre-contractual relationship; - Fulfilment of legal obligations (e.g. obligations arising from contracts and health and safety at work regulations); - Administrative and fiscal management of contracts and orders; - Response to requests for information or support. The legal basis for data processing is the fulfilment of contractual and pre-contractual requirements and legal obligations, for which Reg. (EU) 2016/679 does not provide explicit consent.
Data processing procedures	GRUPPO PIANTONI HOLDING Srl processes the users' personal data by adopting appropriate security measures to prevent unauthorised access, disclosure, modification or destruction of personal data . Processing is carried out by means of IT tools, web tools and paper , in accordance with principles of fairness, legality and transparency in order to protect the confidentiality and rights of the data subjects, in compliance with the provisions of current legislation.
Categories of data processed	In the management of contractual and pre-contractual relations, GRUPPO PIANTONI HOLDING Srl processes the following data relating to your staff responsible for the execution and management of contracts: name, surname, contact details, e-mail addresses, professional qualifications where relevant, any data relating to wages and contributions paid and certificate of social security compliance in relation to the staff employed by you for the provision of services in the companies of our Group, when such data are necessary to carry out checks on compliance with the rules for the protection of workers in tender procedures, any data of legal representatives, including any judicial data required by law - whether they are directly provided by you or obtained from public sources (e.g. Chambers of Commerce). The data will be processed by the companies of our Group in compliance with Reg. (EU) 2016/679 and national legislation, including any provisions issued by the Supervisory Authority, where applicable.
Personal data recipients or categories of recipients	The following could have access to the personal data: <ul style="list-style-type: none"> - authorised personnel as defined in Art. 29 of the Reg. (EU) 2016/679; - external parties appointed as data controllers pursuant to the provisions of Art. 28 Reg. (EU) 2016/679.
Personal data storage period	Personal data are processed for the time required to fulfil the aforementioned purposes. Different times are provided for the fulfilment, by the Controller, of the obligations imposed by the regulations in force (e.g. statutory obligation of at least 10 years for processing for administrative and tax purposes).
Personal data storage location	The personal data are processed and stored at the operational headquarters of the companies belonging to the GRUPPO PIANTONI HOLDING Srl and in any other place where the parties involved in the processing are located.
